Payment shall be made under one only of sub-section (1) to (6) in respect of any one occurrence and the total liability of the Company shall not in the aggregate exceed the sum of kyats 1,000,000 during any one period of insurance.  - any accidental loss, damage or liability caused, sustained or incurred

 (a) outside the Geographical Area of the Republic of Union of Myanmar
 - (b) whilst on the Insured's order or with his permission or to his knowledge the Motor Vehicle is
 - being used otherwise than in accordance with the Use as indicated in the proposal.
 - (ii) being driven by any other person than a Driver who is properly licensed and qualified to drive the class of the Motor Vehicle insured
- any accident, loss, damage or liability directly or indirectly, proximately or remotely occasioned by, contributed to by or traceable to or arising out of or in connection with flood, windstorm, rainstorm, typhoon, hurricane, volcanic eruption, earthquake, landslide, landslip or subsidence, invasion, the act of foreign enemies, hostilities or warlike operations (whether war be declared or not) civil war, mutiny, rebellion, revolution, insurrection, military or usurped power or by any direct or indirect consequences of any of the said occurrences and in the event of any claim hereunder the Insured shall prove that the accident, loss, damage or liability arose independently of and was in no way connected with or occasioned by or contributed to by or traceable to any of the said occurrences or any consequences thereof and in default of such proof the Company shall not be liable to make any payment in respect of such a claim.
- any liability which attaches by virtue of an agreement but which would not have attached in the absence of such agreement.
- 4. (a) any accident, loss or damage to any property whatsoever, any loss or expense whatsoever resulting or arising therefrom or any consequential loss
